Part A: Pupil premium strategy plan

Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy is also integral to wider school plans for education recovery, notably in its targeted support through the National Tutoring Programme for pupils whose education has been worst affected, including non-disadvantaged pupils.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

When diagnosing pupil's needs, we look very closely at the individuals rather than groups. Cohort sizes are variable and data of groups is therefore often unreliable.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

2021-22 outcomes:

The remote learning offer was carefully monitored by staff in cases of absence. Barriers to learning was captured and staff worked to reduce the barriers. All actions were monitored.

Two members of staff attended Mental Health First Aid training and this enhanced support given to pupils and parents, and the guidance and advice given to staff on how best to support our pupils.

Monitoring of books demonstrated that pupils were receiving a broad curriculum and attitudes towards learning were positive. Productivity in books increased and presentation improved.

Staff worked collaboratively with parents and the pupils to improve attendance. Families were also supported by the Trust Attendance Officer. Overall attendance at the end of last year was 93% and Persistent absentees were 16.7%.

Our assessments and observations indicated that pupil behaviour, wellbeing and mental health improved considerably, after the uncertainty and challenges of the previous year, primarily due to COVID-19-related issues. We used pupil premium funding to provide wellbeing support for all pupils, and targeted interventions where required. Enriching and joyful experiences were subsidised to support all pupils to access enriched experiences.

Timetables were reviewed to ensure that pupils were receiving discrete sessions that would support social and emotional aspects of learning.
